

## **\$500 Glamping Voucher Giveaway Terms & Conditions**

By entering this promotion, each entrant agrees to be bound by these Terms & Conditions. The promoter is Suzuki New Zealand of 1 Heads Road, Whanganui (the Promoter).

1. Promotion period starts 00:01 on Wednesday 29 April 2026, and ends at 23:59 on Tuesday 12 May 2026.
2. Eligibility: Entry is open to residents of New Zealand who are aged 18 years or over. Employees (and immediate family members) of the Promoter and any agencies or suppliers associated with this promotion are not eligible to enter.
