

# Win a Jimny Competition Terms and Conditions

## How to Enter

- Purchase any new Suzuki 4-stroke outboard engine from the DF15 and DF60hp model range to receive one entry into the draw.
- Excludes demo units and all other promotion.
- Purchase must be made through participating authorised Suzuki dealers during the Promotion Period to qualify.

## Eligibility

- The competition is open to all New Zealand residents with a current residential address in New Zealand, aged 18 years or older with a full New Zealand driver's license.
